### **Meeting Minutes**

#### **Call to Order – Flag Salute**

1. Meeting called to order at 7:01 PM.

#### **Roll Call**

Present: Sheila Lyons (Chairperson), Kurt Almond (Vice Chair), Roy Barba (Treasurer), Michael Aarons, Jim Wortner, Juan Soto Absent: Don Clark and Thomas Edel.

#### **3. Minutes of the Previous Meeting(s)**

Corrections to November minutes prepared by Roy Barba were discussed and approved. Motion to approve November minutes was made and seconded; motion carried. Minutes from August and October still need to be completed.

#### **4. Public and/or CAB Member Comments (Items NOT on the agenda)**

- Juan Soto was welcomed as a new member.
- Discussion about potential new members, including Brian Minor, who remains interested but is currently busy with farming activities.

#### **5. Public Safety Reports**

##### **Sheriff's Department:**

Sergeant Slane (North Station) reported an uneventful December: one battery, two trespassing calls, one suspicious circumstance, and 14 patrol checks. Community feedback noted increased visibility of patrol cars. Nine new deputies graduated in January; more are in training. A question about drones and lights at the Nancy Wood Room was addressed—these were related to a TV production, not law enforcement.

##### **CAL FIRE:**

Captain Jesse Ryan reported from Nov 19 to Jan 21: 43 medical aids, 6 structure fires, 14 traffic collisions, 7 fire alarms/smoke checks, 2 power line incidents, and 2 vehicle fires (one large commercial). Noted a significant increase in lithium battery fires; advised safe charging practices and regular battery checks. Discussion about battery safety, fire risks, and recent structure fires.

**CHP:**

A CHP representative did not attend this meeting. No report filed.

**6. Fifth District Supervisor Report - Jennifer Kinnear, Chief of Staff**

Updates from Supervisor Moreno's office included:

- Caltrans will address water flow issues at the end of Swayze Road.
- PG&E has been upgrading lines on Webster to reduce future outages.
- Cal Portland's sand mining permit is under review; Fish and Wildlife response is pending.
- District 5 newsletter launched; community members can subscribe for updates.

- Parks and Recreation master planning is underway; input from the Garden Club is encouraged.

Decision agreed to, to Skip Item #7 to be after Item #8.

**8. Planning Department Update & Project Referrals - Dominic Del Porta, SLO County Department of Planning and Building****Lot Line Adjustment Enholm N-SUB2025-00084:**

Roy Barba, CAB Area Rep for this project, lead discussion of a two home major lot line adjustment at 2390 and 2396 La Panza Rd resulting on one home for each property by reconfiguring internal property lines for estate planning and home placement. Site visit conducted; Recommendation of motion to approve was made by Roy Barba, 2<sup>nd</sup> by Sheila Lyons, ensuing vote was unanimous to accept motion.

**Code Enforcement:**

Updates on Stanger and Jhelum Vineyards: Stanger's case closed; Jellum has permits in process. Cell tower permits are ready for issuance; minor road improvements may be required for access.

**Cell Tower:** Dominic Del Porta announced that the permits for the two cell towers proposed for Creston are done and ready pick up.

**Cannabis Projects:**

No significant updates; community efforts to monitor compliance continue.

**7. New Business****a. Proposed Transportation Tax Increase Discussion:**

A comprehensive presentation was given regarding the possibility of placing a transportation tax using a SLO County sales tax increase of 0.5% on the November 2026 ballot. The discussion highlighted the following key points:

- **Background:**

The state distributes transportation funding through the State Transportation Improvement Program (STIP), primarily funded by the gas tax (SB1). As more residents drive less and switch to hybrid or electric vehicles, the county's share of state funding has decreased. Neighboring counties (Santa Barbara, Monterey, Santa Cruz) have implemented voter-approved transportation taxes, generating significant local revenue—over \$100 million in 2024 alone—while San Luis Obispo County has not yet adopted such a measure.

- **Funding Structure:**

The proposed tax would generate approximately \$35 million per year. Of this, 55% would be distributed among the eight jurisdictions in the county (including unincorporated areas) for local road repairs, safety, and improvements, allocated based on population. The remaining 40% would fund regional capital and corridor improvement programs, with 4% set aside for transportation services for seniors, people with disabilities, and veterans, and up to 1% for administrative costs.

- **Local Control and Oversight:**

Funds collected would remain local, with each jurisdiction deciding how to spend its share. A Citizens Oversight Committee, including representatives from each supervisorial district and city, would monitor compliance and ensure fiscal integrity. Annual audits would be conducted to maintain transparency.

- **Community Input:**

Community Advisory Committees (CACs) would meet twice per two-year programming cycle to provide priority lists and feedback on project needs. The plan aims to address both major infrastructure projects and smaller, critical improvements like Safe Routes to School.

- **Tax Details:**

The proposed increase would be a 0.5% sales tax, not applied to housing, medical, or groceries. Tourists would also contribute through purchases, benefiting local infrastructure.

- **Discussion Points:**

Members raised questions about the impact of declining gas tax revenue, the possibility of taxing electric vehicles, and the fairness of funding distribution. The importance of leveraging local funds to attract state and federal grants was emphasized. Concerns were voiced about ensuring equitable benefits for smaller communities like Creston and maintaining current levels of road spending by cities.

- **Next Steps:**

The draft expenditure plan will be reviewed by the SLOCOG Board of Directors on February 4th, with further approvals sought from cities and the county before finalization in April and voter decision in November.

**Action:**

No formal vote was taken, but feedback was provided for consideration in the final plan.

**b. Moratorium on Treated Sewage Sludge:**

Discussion about the county's recurring moratorium on spreading treated sewage sludge. Concerns raised about water quality and long-term impacts to soils and the community. Motion made by Sheila, 2<sup>nd</sup> by Jim, to draft a letter will be prepared by Kurt, reviewed by Sheila, supporting a continued ban, focusing on longer term water/ soil protection; motion carried with all ayes, except Roy who abstained.

**c. SLO Bike Club Wildflower Ride:**

The club requested approval for their annual event in Creston. The County is requiring CAB approval prior to issuing them a permit. Motion to approve the event was made by Jim and seconded by Kurt;

motion carried unanimously. Discussion about logistics, including porta-potty placement and community benefits.

#### **9. Use of AI for Meeting Minutes:**

The group discussed using AI-generated summaries as official minutes, with human review for accuracy. Consensus to trial this approach, with summaries posted for review before ratification at the next meeting. Motion made by Roy, 2<sup>nd</sup> by Jim. Carried unanimously.

#### **10. Paso Basin Cooperative Committee Report**

Murray Powell reported on water usage, cannabis project compliance, and upcoming meetings. Noted ongoing challenges with outreach and funding for water projects. Next PRAGA meeting February 18<sup>th</sup>. There will be a meeting with DWR to discuss “dry wells” and management tools/objectives. Murray will try to attend even though he was not invited.

#### **11. Committee Reports**

##### **a. By-Laws:**

No updates.

##### **b. Elections:**

Juan Soto seated as new CAB District 2 representative; incumbents of even numbered CAB areas to announce intentions for re-election at February CAB Meeting. Sheila distributed Attachment D from By-laws, Conditions of Service form to be completed by incumbents who are up for election again. This included Kurt & Mike. Post meeting Sheila emailed form to Don Clark.

##### **c. Public Information:**

Website updates and community outreach discussed.

#### **12. Treasurer’s Report**

Roy Barba reported a balance of \$1,201.12. \$200 dues for CATCH to be paid as standard. Roy will file paperwork with the County for the next year of funding using new forms from County.

#### **13. Additional Public Comment**

Comments on Christmas decorations and road safety (rumble strips). Discussion about community events, rodeo board participation, and volunteer engagement.

#### **14. Adjournment**

Meeting adjourned at approximately 8:49 PM.
